

**Thank you for purchasing K&H Manufacturing's Hangin' Kitty Condo. Proper care and adjustment should lead to many years of pleasure for your cat.**

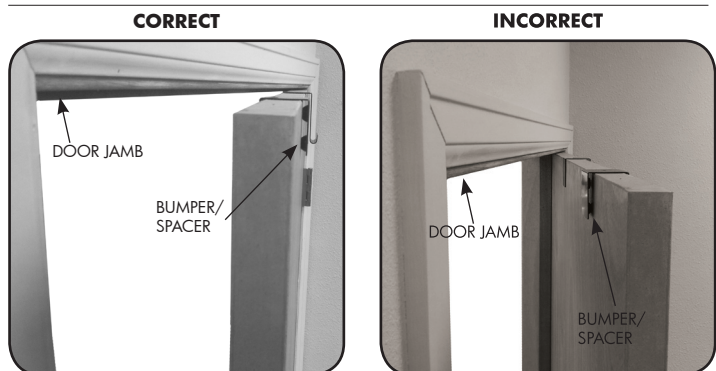
### What is in the box?

(1) 600 denier Nylon with a vinyl backing Hangin' Cat Condo frame; (2) Black corrugated side panels; (3) Brackets; (4) Bumper/Spacers  
Note: Small size Hangin' Kitty Condo has a total of 4 door brackets. The Large size Hangin' Kitty Condo comes with 5 brackets.

**1 Installation of door brackets:**  
Install top door brackets. Our unique door bracket system is made to fit virtually any standard household door. For most thicker exterior doors, i.e., front or back door of a home, the bracket can be used as is. For thinner interior doors such as a bedroom or closet door, we've provided stick-on silicone bumper/spacers to help remove excessive gap between the bracket and the door. When using the bumper/spacers, always determine first which side of the door your new Hangin' Kitty Condo will hang on. The bumper/spacers should be attached to the inside of the bracket **OPPOSITE** of the door jamb (See figure 1). (Never put the bumper/spacers on the door jamb side of the bracket as this may prevent the door from properly closing.)

*Bumper/Spacers have been placed on the opposite side of the door from the door jamb, allowing the door to close properly.*

*Bumper/Spacers have been placed on the side of the door that closes into the door jamb, not allowing the door to close properly.*

**2 Installing your Hangin' Kitty Condo:**  
1. Remove all contents from packaging taking care not to lose any parts.  
2. Find the top of the Hangin' Kitty Condo. (The end with the long straps is the **BOTTOM** of the Hangin' Kitty Condo)

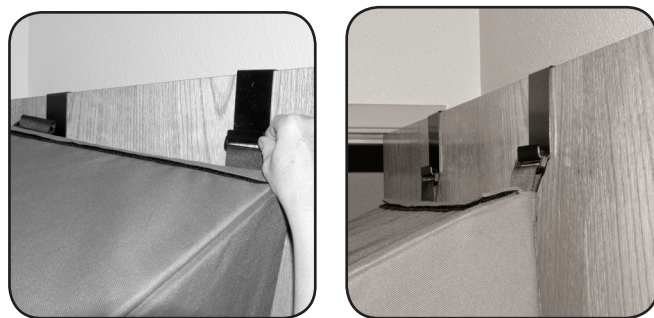

3. Locate and install the black corrugated side panels into the pockets shown in **figure 2**. To do this, open the hook and loop enclosure pockets on both sides of the top section of the Condo. Slide the panels into the pockets. Be sure to note the orientation of the black panels as they only fit into the pockets one way. Once you have completely inserted the corrugated plastic side panel, close the flap and secure the hook and loop flap. Repeat on the other side. See **figure 2**.

4. Attach your Hangin' Kitty Condo to the brackets hanging on top of your door. The clips on top of your condo simply slide over the hook on the bottom of the door bracket. Note: The small Condo has 2 top door brackets. The large uses 3 top door brackets. See **figure 3**.

5. Slide 2 door brackets onto the bottom of your door. Adjust them accordingly so your Condo hangs straight.

6. Attach bottom adjustment straps to the brackets and pull the cinch strap lightly on the right and left side. See **figure 4**.

7. Step back and adjust the Hangin' Kitty Condo on the top, and/or bottom. Be sure it is visually straight and where you want it.

8. Lastly, firmly pull down on each cinch strap to secure.



**With proper installation, your new Hangin' Kitty Condo will be a secure, safe, space saving addition to your home.**

**Care Instructions:** When Hangin' Cat Condo is removed from packaging it is safe to steam in order to remove unwanted wrinkles. To clean wipe with a damp cloth
